WHERE and WHEN:

The Rochester Art Club 2020 Art Exhibition will go live online at RochesterArtClub.org Friday, November 13th, 2020. The show will continue through Monday January 17th, 2021.

Show Reception: A reception on Zoom will be announced via email.

JUROR FOR AWARDS: Michelle Dunaway

Michelle Dunaway is an American artist whose paintings are revered for their bold brushwork yet sensitive portrayal of emotions that capture the human experience. Dunaway exhibited a strong penchant for drawing the human form from a young age and that fascination has continued throughout her life and career. Her artwork has been featured in international exhibitions and publications including *Fine Art Connoisseur*, *Art of the West*, *International Artist*, *American Art Collector*, *Southwest Art*, and *American Artist*.

Dunaway's work has received numerous awards and honors including Finalist and Award of Exceptional Merit at the 2010 Portrait Society of America's International Portrait Competition for her painting *Katie and Jenni -The Daughters of Jane Seymour*; a Certificate of Excellence from the Portrait Society of America in 2014 and 2017; Finalist and Award of Exceptional Merit at the 2016 Portrait Society of America's International Portrait Competition; and Finalist in the Art Renewal Center's ARC Salon Competition. She was also a featured invited artist at the 2014 California Art Club Gold Medal Exhibition.

JURY PROCESS INFORMATION:

Because this is the first attempt for many in our membership at photographing their work, applying electronically to a show, judging and exhibiting online, and because Michelle Dunaway requested, we will NOT be eliminating anyone's art from this show. This WILL count toward associate members's tally toward signature membership. This is a one time favor as our members get used to this new process.

ENTRIES:

- You may submit your digital images online at showssubmit.com.

- Up to 3 digital images are allowed.
- Show only the artwork, no frame.
- A non refundable entry fee of \$10 per image is required. This entry fee is paid via credit or debit card through showsubmit.com.
- DEADLINE for entry is midnight on Thursday, October 22, 2020.
- Images should have a maximum of 1600 pixels on the longest side, with a resolution of 72 dpi/ppi. Total file size must be under 2 MB. If your file is 1600 pixels on the longest size and larger than 2 MB, you'll have to reduce the 1600 to get it under 2 MB.
- The file must be saved in high quality .jpg format, with the file name consisting of the artist's last name, underscore, first initial, underscore, PaintingTitleWithoutSpaces, .jpg. (For example: Jones_D_SummerFun.jpg.) The title may be abbreviated if necessary.
- Medium, size, price/NFS, etc. are information you can add during the entry process.

RULES OF ENTRY:

- Associate members ARE eligible to enter this exhibit
- All entrants must be a member in good standing as of September 30, 2020.
- Entries must have been created within the last two years and may not have been shown at any previous RAC or other juried show within Monroe County.
- All aspects of the entry must be the artist's original work including subject, photography, composition, drawing and painting.
- Entries may not be produced in any instructional class or workshop.
- No diptych or triptych paintings, mechanical reproductions, photography, crafts or computer generated art.
- 3-D art is acceptable for this show.
- Nudes are acceptable for this show.
- There is no limit on size.

The artist grants permission to reproduce work for digital publicity purposes. Copyright will be attributed to the artist. Entry into this exhibition constitutes agreement with all conditions set forth in the prospectus and entry form and is your commitment to participate.

AWARDS:

Best of Show Award (\$100 cash), Rochester Art Supply Award (\$50 gift card), six Juror Awards (\$50 cash), and six Merit Awards (\$25 cash). Only one award per member is allowed.

SALES:

All sales of paintings are to be handled by the individual artist. Any purchase inquiries will be channeled through the RAC's email and forwarded to the artist. The artist is responsible for deciding whether to include shipping costs and/or any applicable sales tax in the price listed.

The artist handles the packaging and shipping and agrees to ship the art within 10 days of purchase.
